It is our pleasure to announce that the Anne Arundel County Department of Recreation & Parks is offering a full-day Pre-K SUMMER child care-licensed program at the South County Recreation Center (4510 Owensville Sudley Rd. Harwood, MD. 20776) for seven weeks during the Summer of 2025. The Summer Pre-K program is designed to address the safety, social & recreational needs of the children in their care.

Summer activities include the following: AM snack, literacy time, outdoor play (weather permitting), arts & crafts, rest time, and organized games. Children currently served by the Rec & Parks school year Child Care program will receive priority registration at the child care center during the month of January, then registration will open online February 3, 2025 to the general public for any remaining spaces.

ELIGIBILITY:

- **AGE:** Children 3, 4 & 5 years old as of June 23, 2025 are eligible to attend the program. Children must be toilet trained. If your child has a special medical/behavioral need, you must contact the Child Care Administrative Office to set up a parent conference prior to your child attending the program.
- **STATE MANDATED FORMS:** Every child **MUST** have the State mandated forms completed and on file at the site prior to their first day of attending. **No one will be permitted to attend without this information on file. Health Inventory requires a physician's signature.**
 - **NEW Participants:** You can download the **Required Forms for Admission** on our website.
 - **CURRENT School Year PRE-K Participants:** Paperwork for current PRE-K participants will be copied and transferred from your school year file to your summer file. Current School Year parents will be asked to update forms by the staff on site, as needed.
