- <u>Summer Fee Schedule</u>: You must pay for the summer program on a bi-weekly basis ahead of service. If your needs should change during the summer and your family no longer needs care, you must email us at <u>sacc@aacounty.org</u> to withdraw.
- **<u>Refund Policy:</u>** A \$25 processing fee will be assessed on all refunds. 10 business days' notice is required for all summer refunds. 10 business days' notice is also required for all requests to transfer fees between summer weeks. Weekly payments may be transferred between summer weeks ONE time ONLY. All refund requests for medical reasons must be accompanied by a physician's note and are handled on a case-by-case basis. All refund requests must be made in writing to the Child Care Administrative Office.

## ELIGIBLITY:

- AGES: Children MUST be entering 1<sup>st</sup> through 6<sup>th</sup> grade for the 2025-2026 school year to be eligible to attend Summer SACC.
- STATE MANDATED FORMS: Every child MUST have the State mandated forms completed and on file at the site prior to their first day of
  attending. No one will be permitted to attend without this information on file. Health Inventory requires a physician's signature.
  - NEW Participants: You can download the Required Forms for Admission on our website.
  - **CURRENT School Year SACC Participants:** Paperwork for current SACC participants will be copied and transferred from your school year site to your summer site. Current School Year parents will be asked to update forms by the staff on site.
- **TOILETING:** Children must be toilet trained. Your child must be able to be self-directed & self-sufficient in the restroom and able to care for their own hygiene needs. *Please contact our office at 410-222-7856, ext.0 to schedule a meeting to discuss toileting assistance if your child has a diagnosed special need.*
