The subject property is zoned R2 - Residential District and is located in a stand-alone building. The proposed use is marina offices and store on the first floor and a tavern in the basement. §18-5-102 of the Anne Arundel County Zoning Ordinance allows taverns as a permitted use in the R2 District.

Upon review of the subject application, this Office finds that the proposed use meets the conditional use requirements for alcoholic beverage uses under Section 18-10-104 of the Code as well as the general requirements for alcoholic beverage licenses under 18-2-109. Accordingly, this Office would have **no objection** to the issuance of the requested liquor license.

The applicant is advised that building and/or grading permits are required for all renovation and/or new construction. Additionally, a Zoning Certificate of Use is required for the subject use.
