

DESCRIPTION OF THE SIXTH PRECINCT OF THE
SIXTH COUNCILMANIC DISTRICT OF ANNE
ARUNDEL COUNTY, MARYLAND

BEGINNING FOR THE SAME at the intersection of Bay Ridge Avenue and Forest Hills Avenue, and from said beginning point so fixed and with the centerline of Forest Hills Avenue in a westerly direction to its intersection with the centerline of Bricin Street;

THENCE with the centerline of Bricin Street in a northerly direction to its intersection with the centerline of Janwall Street;

THENCE with the centerline of Janwall Street in a northeasterly direction to its intersection with the eastern boundary of Census Block 240037064042003;

THENCE with the eastern boundary of Census Block 240037064042003 in a northerly direction to its intersection with the centerline of Tyler Avenue;

THENCE with the centerline of Tyler Avenue in a northeasterly direction to its intersection with the centerline of Hilltop Lane;

THENCE with the centerline of Hilltop Lane in a northwesterly direction to its intersection with the centerline of ~~Primrose Road~~ Garden Gate Lane;

THENCE with the centerline of ~~Primrose Road~~ Garden Gate Lane in a ~~southeasterly~~ southwesterly direction to its intersection with the ~~northwestern boundary of Census Block 240037064031011~~ Rosecrest Drive;

~~THENCE with the northwestern boundary of Census Block 240037064031011 in a southwesterly direction to the northwestern boundary of Census Block 240037064031012;~~

~~THENCE with the northwestern boundary of Census Block 240037064031012 in a southwesterly direction to its intersection with the centerline of Forest Drive (Maryland Route 665);~~

THENCE with the centerline of Rosecrest Drive in a southwesterly direction to its intersection with Forest Drive (Maryland Route 665);

THENCE with the centerline of Forest Drive (Maryland Route 665) in a southeasterly direction to its intersection with the northwestern boundary of Census Block 240037026014003;

THENCE with the northwestern boundary of Census Block 240037026014003 in a southwesterly direction to its intersection with the southern boundary of Census Block 240037026014003;

THENCE with the southern boundary of Census Block 240037026014003 in a southeasterly direction its intersection with the eastern boundary of Census Block 240037026014003;

THENCE with the eastern boundary of Census Block 240037026014003 in a northeasterly direction to its intersection with the centerline of Forest Drive (Maryland Route 665);

THENCE with the centerline of Forest Drive (Maryland Route 665) in a southeasterly direction to its intersection with the centerline of Bay Ridge Avenue;

THENCE with the centerline of Bay Ridge Avenue in a northwesterly direction to its intersection with Forest Hills Avenue and the place of beginning;

BEING the Sixth Precinct of the Sixth Councilmanic District of Anne Arundel County.
