1 RESOLUTION appointing members to the Public Campaign Financing System
2 Commission

4 WHEREAS, § 1-12-110 of the County Code creates the Public Campaign Financing
5 System Commission (the “Commission”) and establishes the membership of the
6 Commission; and

7
8 WHEREAS, membership includes one member from each councilmanic district
9 appointed by the County Council; and

10
11 WHEREAS, § 1-12-110 further provides that each member shall serve a term of four
12 years, that each member of the Commission shall be a resident of the County while
13 serving on the Commission, and that no more than five members may be of the
14 same political party; and

16 WHEREAS, each Councilmember has recommended a resident of their
17 councilmanic district to serve on the Commission, as follows: Marsha
18 Jackson – District 1 (Democrat), Kenneth Vinston – District 2 (Democrat), Erik
19 Robey – District 3 (Republican), Spencer Dixon – District 4 (Democrat), Michael
20 Leahy – District 5 (Republican), Nadine Chien – District 6 (Democrat), and
21 Matthew Dalton – District 7 (Republican); and

23 WHEREAS, the County Council finds that the residents recommended meet the
24 eligibility requirements for membership on the Commission; now, therefore, be it

26 *Resolved by the County Council of Anne Arundel County, Maryland,* That it appoints
27 Marsha Jackson – District 1, Kenneth Vinston – District 2, Erik Robey – District 3, Spencer
28 Dixon – District 4, Michael Leahy – District 5, Nadine Chien – District 6, and Matthew
29 Dalton – District 7 to the Public Campaign Financing System Commission for four-year
30 terms beginning April 1, 2025; and be it further

32 *Resolved,* That a copy of this resolution be sent to County Executive Steuart Pittman,
33 Tom Ni, Boards and Commissions Coordinator, and the appointees of this Commission.
